
In exercise of powers conferred under Sec.5 & 6 of O.E.Act, 1969, the committee constituted vide Government Notification No. 15641 /HE, Dt.1.5.2004, in their meeting held on **03.04.2018** and Govt. letter No.9950/HE,dt.06.04.2018 after careful consideration have been pleased to grant permission for **opening of Degree College** as Self financing College in favour of under named institution from the session 2018-19 as per the details mentioned below:-

1. Name of the Institution :- Vishwa Vinayak Degree College
2. Name of the Agency applied for :- Vishwa Vinayak Charitable Trust
3. Address:- Khireitangiri
4. Name of the Block :- Patana Dist-Keonjhar

*The above permission is subject to fulfillment of the following terms and conditions.*

- i. The State Govt. shall not bear any financial liability at any point of time nor the agencies of the G.B. shall claim grant - in- aid from the State Government.
- ii. Fire proof college building holding required number of class and administrative rooms as prescribed in the O.E. Rules, 1991 has to be constructed in its own registered land in the name of the college.
- iii. Qualified faculties per subjects as per UGC guidelines with necessary Ph.D/NET/M.Phil qualification shall be appointed by the agency. There should be minimum of two teachers in each subjects for a strength of 16 students. For every extra number of classes one more will be required. Non-teaching staff should have requisite knowledge in computer and accounting. There should be minimum two clerks, two peons with strength of 64 students. The faculties should have been selected through Interview process and must have the endorsement of the subject experts.
- iv. All conditions prescribed in Section 6 (A) of the O.E. Act. 1969 should be fulfilled to be eligible for recognition.
- v. Necessary application for recognition Under Section 6 (I) in the O.E. Act. 1969 shall be made in duplicate in form No. II with requisite fees to the R.D.E., Bhubaneswar by end of the Session August 2018, from the date of functioning along with the affidavit attesting that all information furnished are true and correct to the best of the knowledge of the deponent.
- vi. An undertaking swearing that institution shall not claim any additional financial aid from the Govt. at any point of time.
- vii. The agency should have its own land of (2 Ac. in Urban area/ 5 Ac. in rural area) and ROR register in the name of institution/ Agency and should have its own building as per the specification issued vide Govt. letter No.8730/HE,dt.22.04.2015 within one year and possession certificate from the concerned Tahasildar to the effect that the institute building is situated over its own land.
- viii. The Fee structure should be reasonable.
- ix. The salary of the staff should be paid through paid bank account.
- x. To fulfill the conditions as per undertaking dtd.28.04.2018 to deposit Rs.7.5 Lakhs towards pledged money.
- xi. 50% of the pledged money will be foreited in respect of the institution if it is unable to run the institution after availing all the provisions extended by Govt.
